- Floor-to-ceiling, impact-resistant windows and sliding doors are designed to flood interiors with natural light.
- Residences feature gypsum ceilings up to 10'6" high, emphasizing openness and light within layouts shaped by contemporary architectural principles.
- Private terraces wrap each residence, flowing from living areas to primary bathrooms, set against a backdrop of refined landscaping.
- Four private elevators provide password-protected access directly into each home.
